

Minutes of the Florida Keys Amateur Radio Club Meeting

Old Business:

The [minutes](#) of the December Club Meeting were approved. Motion made by WA4JFJ and seconded by KA2BYU and approved by voice vote.

Treasurer, WA4JFK reported we have 19 paid members for 2026. The Club currently has \$3,241.39 in the Treasury. **A total of \$2,074 remains for the Grassy Key Tower Project.**

K1ST will be away for the March Club Meeting. **Need someone to run the meeting. Contact K1ST.**

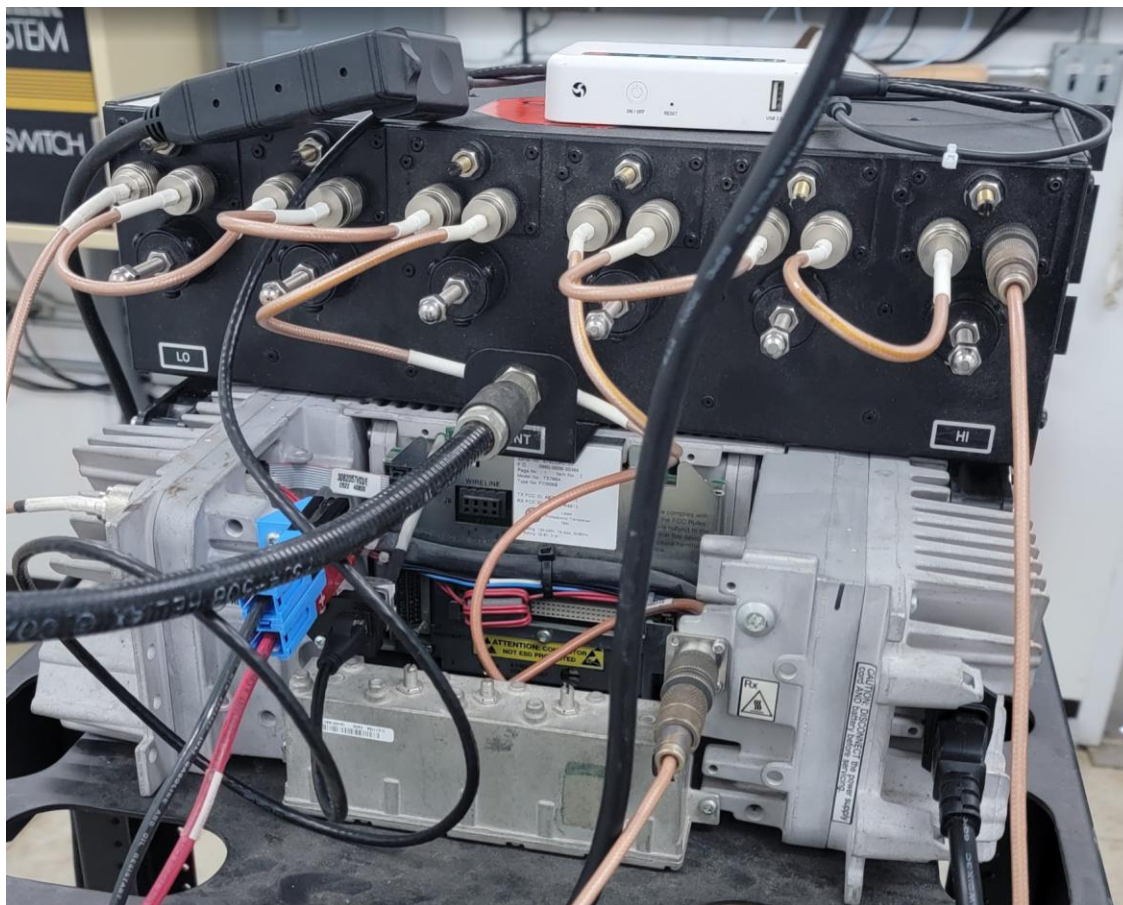
New Business:

GMRS Repeater Status from KA2BYU. ORC GMRS Repeater may have a blown Power Amplifier. **Layton GMRS is online on a new antenna on the tower.**

Ham Repeater Status from K1ST. **The UHF Repeater for Key Largo (at the State Rd 905 Transfer Station) is online as of January 5th and initial reports are that it is working quite well. High power mobile coverage should be in the 50 mile range. The antenna is a [DB420](#). It has a cardioid (figure 8) pattern pointing up and down the Keys. Antenna is 340 feet up the tower and has a gain of 10.4 dBi. Battery back up for the Repeater was added January 9th. There is no generator at the site. The**

battery backup and duplexer for this repeater came from the paging transmitters on Plantation Key which were retired last summer. See photos of the Repeater below. Materials for the Allstar Link have been received. The Club voted to approve the reimbursement of K4HG for \$72 and K1ST for \$897.24 for the expenses for this repeater.





The tower crew for the Grassy Key Tower Project is scheduled to arrive February 2nd.

The Tuning of the replacement duplexer for the ORC FM Repeater has been delayed to February.

K1ST requested the Club purchase two Lenovo N23 Chromebooks for \$70.20 for evaluation to use at the Repeater Sites for remote Repeater configuration changes. The Club approved the purchase, KA2BYU ordered the units and they are scheduled to arrive on January 14th.

KA2BYU had to HF power amplifiers for sale at the meeting. An Ameritron 84 with one soft 6MJ6 tube for \$300 and an Ameritron 811H with spare 811A tube for \$850. K4VRZ bought the Ameritron 84. Contact KA2BYU if you're interested in purchasing the 811H (good price!). The amplifiers are owned by the Keys Cares Club.

K1ST sold a DM-1701 to K3OCM and has one remaining for sale for \$45.
